ON 04-18-14 DESIREE CAPUANO BECAME A VICTIM OF HARASSMENT WHEN HER EXHUSBAND, SP1 RICHARD RIESS CREATED A LINK ON DESIREE'S LINKEDIN BUSINESS PROFILE SHOWING AN ARREST RECORD WITH A MUG SHOT AND SENT OUT EMAILS FROM DESIREE'S ACCOUNT TO ALL OF HER PROFESSIONAL CONTACTS SHOWING THEM THE LINK.

ON 04-18-14 I CONTACTED DESIREE CAPUANO IN REFERENCE HARASSMENT SHE IS RECEIVING FROM HER EX-HUSBAND, RICHARD RIESS.

DESIREE TOLD ME THAT BOTH HER AND RICHARD HAD FAMILY COURT IN COMPTON CALIFORNIA GIVING DESIREE A MAJORITY OF THE CUSTODY OF THEIR CHILD IN COMMON. DESIREE STATED THAT RICHARD WAS UPSET OVER THE RULING AND NOW IS HARASSING HER THROUGH THE COMPUTER. DESIREE WORKS FOR THE APOLLO GROUP WHO OWNS UNIVERSITY OF PHOENIX. DESIREE STATED THAT RICHARD HAD SOMEHOW CREATED A LINK ON HER LINKEDIN PROFILE AND SHOWED DESIREE'S ONE ARREST RECORD, HER MUG SHOT AND PERSONAL INFORMATION. WHEN DESIREE HAD LINKEDIN PULL THE LINK, RICHARD SOMEHOW SENT A MASS EMAIL TO OVER 200 PEOPLE FROM DESIREE'S LINKEDIN ACCOUNT WITH THE SAME INFORMATION. THE MASS E-MAIL WAS SENT OUT TO ALL OF THE EXECUTIVE OFFICERS AT THE APOLLO GROUP.

DESIREE FEELS THAT RICHARD IS HARASSING HER AND BELIEVES HE IS TRYING TO GET DESIREE FIRED FROM HER JOB BECAUSE OF THE ONGOING COURT BATTLE IN FAMILY COURT.

RICHARD LIVES IN A SUBURB OF VANCOUVER, BRITISH COLUMBIA AND DESIREE IS GOING TO COURT TO SEE IF SHE CAN OBTAIN AN ORDER OF PROTECTION.

DESIREE DESIRES PROSECUTION AND WILL TESTIFY.

AFTER REVIEW OF THIS REPORT, I SPOKE WITH THE VICTIM DESIREE, THIS HAS BEEN AN ONGOING ISSUE SINCE 2002. THERE HAS BEEN MULTIPLE CUSTODY DISAGREEMENTS, AND DESIREE STATED, RICHARD WHO LIVES IN CANADA, WILL NEVER STOP HARASSING HER. RICHARD HAS CREATED A WEB SITE TO DESIREE AND TO DAMAGE HER IMAGE WITH THE HOPES SHE GETS FIRED AND NEVER WORKS AGAIN. ACCORDING TO DESIREE RICHARD SENDS SEVERAL EMAILS IN REGARDS TO HER MARIJUANA ARREST IN THE PAST, AND CONTINUES TO EXPRESS IN THESE EMAILS AS IF HE, RICHARD, IS DESIREE WRITING THE EMAILS TO ALL HER COLLEAGUES.

DESIREE UNDERSTANDS RICHARD IS IN CANADA, AND SHE STATED RICHARD BELIEVES SHE IS THE PERSON WHO TURNED HIM OVER TO CUSTOMS AND HAD HIM DEPORTED. DESIREE SAID FOR THIS REASON, RICHARD WILL CONTINUE TO DO EVERYTHING IN HIS POWER TO GET HER FIRED. DESIREE ALSO UNDERSTANDS CANADA WILL NOT ASSIST IN ANY TYPE OF PROSECUTION OR ANY ORDER OF PROTECTION.

DURING THIS INVESTIGATION, I WAS ABLE TO SPEAK TO RICHARD, DURING OUR CONVERSATION, RICHARD INFORMED ME HIS REAL NAME WAS PATRICK FOX. RICHARD STATED HE DOES PLAN TO RUIN DESIREE, AND MOSTLY IN PART DUE TO REVENGE FOR WHAT SHE HAS PUT HIM AND THEIR SON THROUGH. RICHARD SAID DESIREE IS THE CAUSE FOR HIM BEING DEPORTED AND ALSO THE REASON HE NO LONGER HAS CUSTODY OF THEIR CHILD, GABRIEL.

ACCORDING TO RICHARD, DESIREE DESERTED GABRIEL AND HIMSELF FOR OVER NINE YEARS, WHILE SHE WAS LIVING WITH SOME OTHER MALE AND DOING DRUGS.

WITH THE KNOWLEDGE THAT RICHARD WAS IN CANADA AND THERE IS NO EXTRADITION FOR HARASSMENT, THIS CASE WILL BE PENDED. ATTEMPTS TO CONTACT THE AUTHORITIES IN VANCOUVER HAVE BEEN UNSUCCESSFUL THUS FAR.
