Breach of Probation x2 & Criminal Harassment Investigation

On September 26, 2019, Version 1 of the RTCC for VPD file 19-49074 recommending charges of Criminal Harassment, breach of probation x2 as well as disobeying a court order. The investigation has continued since that date, as a result, further information and evidence has been collected. Crown Counsel Chris JOHNSON ("JOHNSON") has been assigned as the prosecution and the accused Patrick FOX ("FOX") continues to be held in custody.

Letter from FOX to JOHNSON

On October 23, 2019, Crown counsel JOHNSON received a hand written letter from FOX. Within the letter FOX admits to putting the website www.desicapuano.com online in March of 2019 and demands to be charged with criminal harassment. FOX also states that as soon as he is released from custody he will ensure the website will be put back online and will continue to be updated.

Victim Services Contact

On December 23, 2019, Detective Constable 2671 Jennifer FONTANA ("Det. FONTANA") was contacted by a victim services worker on behalf of the victim, Desiree CAPUANO ("CAPUANO"). The worker advised Det. FONTANA that the website www.desicapuano.com was active again and this was causing CAPUANO a great deal of stress. CAPUANO had been approached by co-workers who had seen the site and were now asking questions. CAPUANO felt that the defamatory comments made on the website could cause her to lose her job and had effected the relationships she had with her co-workers. The victim services worker requested that Det. FONTANA have the website removed.

Det. FONTANA advised the victim services worker that unfortunately the website provider, GoDaddy, had refused to permanently remove the website without a judicial authorization from the United States. Det. FONTANA was able to have the website temporarily removed for 90 days, however that timeline had expired and the website was again accessible.

Links from Website to FOX

Multiple electronic devices were seized on March 15, 2019, off of FOX at the time of his arrest at the United States border. Along with the devices was a set of handwritten notes titled "To Do Website". There were multiple items on the "to do list" and the following items appear to have been completed as they can be located on the website www.desicapuano.com:

- 1) "Compile list of each of DC's perjerious statements."
 - The transcript of CAPUANO's testimony from the first criminal harassment trial has been downloaded onto the website and all the alleged perjury has been highlighted in red
- 2) "Compile list of each of DC's lies in our emails, include a link to the given email."
 - There is no list of "lies" on the website, however personal emails between FOX and CAPUANO have been put on the website.
- "Compile list of each of the times DC laughed and joked with RCMP in 2016-07-13 interview."
 - There is no list, however the transcript of the above mentioned interview has been added to the website. FOX makes reference to the interview in which CAPUANO is laughing and joking with the RCMP and has direct links to the audio recording in more than one location under the R v. Fox section of the website. Clicking the link takes the viewer directly to the audio recording of the nearly two hour interview.
- 4) "Make HTML versions of all of the RCMP incident reports"
 - Links to RTCC versions 1 through 5 submitted by the RCMP have been added to the website in PDF form, no HTML versions were located.
- 5) "Make HTML versions of all the family court docs"
 - Family court documents can be found on the website, however in PDF form, not HTML.
- 6) "Publish recordings of sentencing hearings, and probation hearings, and appeal hearings."
 - Det. FONTANA observed transcripts for the appeal process under the "Restraining Orders Against Patrick" section of the website.
- 7) "Obtain + publish transcripts of 2002-02 fam crt hearings showing the court prohibiting DC from travelling cross country with GR and DC telling the court she will move back to PHX."
 - Det. FONTANA read a section titled "California Family Court Case" on the website. This section claims to have every court document filed between CAPUANO and FOX in relation to the custody battle over their son, Gabriel RIESS.

- 8) "Add commentary about photos of DC's home. Explain the reason they're included is to show how trashy she is (messy, sloppy, home, cheap, unmatched furniture.)"
 - Det. FONTANA located numerous photos of CAPUANO's house, inside and out, can be found on the website. The website is written in the first person as if CAPUANO was making the posts about herself. A blurb above the photos of her bedroom reads "This is where I get nasty, and fuck my brains out...what little I have left, anyway, after all the weed and meth. This is also where I go to get high every day of my life."
- 9) "Add commentary about pets how poor, trashy people always have pets they can't afford."
 - Det. FONTANA located multiple pictures of two dogs, a cat and a rabbit under the "Photo Album: Random Shit" on the website. Above the photos it states "These are just random pictures. You'll notice I have a lot of pets. Why is it trashy people are never able to take care of themselves, yet they always have a lot of pets?"

Court Documents

As stated in the previous overview, the website www.desireacapuano.com with additional information added. FOX was convicted of Criminal Harassment in 2017 for creating and running www.desireacapuano.com, a hate website against his ex-wife, Desiree CAPUANO. FOX was released from custody on December 30, 2018, on March 12, 2019, www.desicapuano.com became active.

The new information on this website consisted of court documents which would have been provided to FOX as a part of disclosure, in order for him to represent himself in court. FOX was bound by a court order which prohibited him from reproducing or disclosing any of the disclosure material to anyone other than his counsel and also prohibited him from publishing, broadcasting or transmitting any information that was provided to him as a part of disclosure unless it is taken as evidence during the trial. The following items pertaining to the original trial, appeal and conviction of FOX can be found on the website:

- Transcripts of police interviews
- Audio recordings of police interviews
- Emails between FOX and the police
- Emails between FOX and crown counsel
- Emails between FOX and outside agencies such as CBSA, Homeland security, ICE
- Affidavits from outside agencies
- Audio recordings of FOX's psychological assessment

Evidence located on Electronic Devices of FOX

At the time of his arrest at the United States border, FOX was found to be in possession of a black Lenovo tablet, Lexar USB, Sandisk micro SD card, nano SIM card and a black Motorola cell phone. These devices were seized by the arresting officers and turned over to Det. FONTANA as a part of the new Criminal Harassment and breach of probation investigation (VA 19-49074).

Det. FONTANA was granted a search warrant for the above mentioned devices by Judicial Justice CHELLAPPAN on June 14, 2019. On June 19, 2019, Det. FONTANA was advised by Detective Constable Nancy YINGLING that an additional 64GB SD card had been located inside the Motorola Cellphone. On August 1, 2019, Det. FONTANA was granted an additional search warrant for the 64GB SD card by Judicial Justice C. ROBERTS.

Det. FONTANA was given access to the data located within the devices by the Digital Forensics Unit and identified a significant amount of data that is evidence of the breach of probation as well as criminal harassment of CAPUANO.

All of the items listed above have been located on the new website

Motorola XT1563 Cellphone/Micro SD Card/SIM Card

Det. FONTANA located multiple text messages and recorded phone calls on the cellphone of FOX which were of evidentiary value to the investigation.

Text Messages

January 28, 2019

1) MUNOZ to FOX "My mom just call me at work she said your package arrived this morning."

January 29, 2019

- 1) FOX to MUNOZ "Oh! Did you confirm the package that arrived yesterday was the hard drive?"
- 2) MUNOZ to FOX "I took a pick :) it did look like it was. Was wrapped on a green bobble wrap. I was tired last night."
- 3) MUNOZ to FOX "I will keep it on the safe with the other stuff."
- 4) FOX to MUNOZ "Thanks."

February 8, 2019

- 1) FOX to MUNOZ "Yeah, but their getting to the end of their rope. I hope to have the new website up by the end of next week."
- 2) FOX to MUNOZ "And it's very slippery. I was going to go to my storage unit to get some notes on the transcripts, but decided against it due to this horrendous weather."

February 16, 2019

FOX to MUNOZ "Just adding the transcripts and shit to the website. I
made HTML versions of the transcripts and I've embedded the audio
recordings into the transcripts so you can actually listen to the trial as
you read the transcripts."

February 18, 2019

- MUNOZ to FOX "OMG just finished listening to the consternation. It sounds clear like water and the other person was very clear on everything he was saying."
- 2) FOX to MUNOZ "So you don't think there's any ambiguity? I was trying to make sure I didn't say anything the Myhre could use to say I was "leading" or hinting to the IRCC guy. I wanted IRCC to be the one to say I has no status."
- 3) MUNOZ to FOX "I don't think so. It sounds like a normal conversation. You didn't sound like you were forcing the other person to say something."
- 4) FOX to MUNOZ "Perfect. Cool. Thanks."
- 5) MUNOZ to FOX "I can't imagine what excuse is Myhre going to come out with."
- 6) FOX to MUNOZ "At my next hearing I'm going to bring that recording, and the letter from social assistance denying my application due to lack of status in Canada."

February 25, 2019

 FOX to KHUDHARI "Check this. Turns out the website has been online all this time. https://web.archive.org/web/20160605104938/http://www.desireecapua no.com/

March 6, 2019

- 1) FOX to KHUDHARI "I spoke with CBSA on the telephone. I recorded it."
- 2) Unidentified sender to FOX "R u sure on the supposed innocent website you were not trying to recruit someone to kill your wife....I mean u did that to me pal...It is known as conspiracy to commit murder....they are not stupid up here either....Bill C51... Csis....U ducked your career up here too pal...Oops....Sorry about that my friend."
- 3) FOX to Unidentified Sender "I would never harm another person except in self-defense, defense of another, or defense of property. That also goes for my ex-wife. I have been very clear about that. All the website does is exposes the bad, the horrible things she has done. Thanks for the feedback."

March 7, 2019

- 1) MUNOZ to FOX "OMG Dude there's so much to read. You sure have time on your hands. Amazingly well organized you even have their pictures. You forgot got the cleaning crew:)"
- 2) MUNOZ to FOX "when they find out they are going to explode of madness."
- 3) FOX to MUNOZ "Youlike the Facebook style blank pictures for the people I couldn't find pictures for? I love that giving the finger. Too funny."
- 4) MUNOZ to FOX "They are going to get mad when they see their pretty pictures."
- 5) MUNOZ to FOX "Oh yeah!! The finger ones:)"

- 6) FOX to MUNOZ "I'm hoping to get a picture of Myhre when I see him at court next week."
- 7) MUNOZ to FOX "If he just knew. Wonder what he is going to try to do when he finds out?"

March 14, 2019

1) MUNOZ to FOX "Dude!! You scare the shittt out of me. Don't be getting arrested AGAIN plz..."

March 15, 2019

- 1) FOX to MUNOZ "Should get it in 5 or 6 days. It's just my laptop."
- 2) FOX to MUNOZ "And the power cord"
- 3) MUNOZ to FOX "Okay. Not problem."

All text messages are included in the Digital Forensic report however the above messages were selected by Det. FONTANA as evidence pertaining to the investigation.

There were also Facebook Messenger messages located, please see the DFU report for the messages in detail.

A number of images were located within the phone, these included pictures of a task log. On the task log the following tasks were listed:

- Call IRCC:
- HTML version of affidavit;
- Add code to embed attached images directly into emails;
- Write blog post "This website is back bitches!"

All of the above tasks correlate directly to items that are found on the website www.desicapuano.com.

Scanned copies of CAPUANO's victim impact statement were located within the phone as well as images of the front page of the new website, and a picture of an advertisement for a school that teaches people how to create websites.

A number of recordings were located within FOX's cellphone, some of which had been deleted. The recordings were of phone calls, incoming and outgoing between FOX and multiple people. The following phone calls were deemed to be of evidentiary value:

March 3, 2019

- 1) Call_14-49-19_OUT
 - call from FOX to MUNOZ;
 - FOX speaks of media reporters Nancy CLANCY and Yvette BREND;
 - The updates to the website are taking longer than he thought
 - Once the updates are on the website MYHRE will be finished mentions having audio recordings
- 2) Call_18-57-40_IN
 - Call from MUNOZ to FOX
 - FOX trying to get a copy of CAPUANO's "Go Fund Me" page she removed it – wants to put it on the website;
 - FOX asks MUNOZ if she saved a copy in the default location on her laptop
 - FOX walks MUNOZ through step by step to locate it
 - FOX tells MUNOZ to check out the new website when he has it up in a couple of days, "so much good stuff;"

March 4, 2019

- 1) Call_10-27-35_OUT
 - Call from FOX to Jana JONES confirming an estimate of \$2125.00 for 580 pages of transcripts

March 6, 2019

- 1) Call 09-51-45 OUT
 - FOX calling an unknown lady;
 - Speaking about travel documents/citizenship;
 - Changed his name from Patrick FOX to Richard RIESS when he was fourteen and ran away from home;
 - Requests records pertaining to Patrick FOX lady states there aren't any;
 - FOX wants his condition prohibiting him from leaving BC to be removed because he can't work in Canada;
 - FOX is told to make privacy requests under both names to IRCC and RCMP.

March 7, 2019

- 1) Call_10-23-57_IN
 - Call from "Anthony" at GoDaddy;
 - FOX identifies himself

- Anthony enquiring if the hosting account set up for website desiapuano.com is meeting FOX's needs, FOX is happy with the service
- FOX mentions he is in the process of downloading the content, website should be live in a few weeks
- FOX plans to set up another site in a couple of months
- FOX will be returning to the United States soon and will be operating the site out of L.A.

2) Call_21-50-45_IN

- Call from MUNOZ to FOX
- FOX tells MUNOZ to check out the website www.desicapuano.com
- FOX states he doesn't want to put the password and username for the website in writing
- Username = Liz
- Password = "same thing I use for everything"

3) Call_22-00-44_IN

- Call from MUNOZ to FOX
- Password worked the first time MUNOZ went into the website but not the second
- MUNOZ comments on how much material is on the site
- A lot of changes to the "Mail" section
- FOX reformatted the emails to make them easier to read
- FOX mentions the website was a lot of work
- MUNOZ worries FOX is exposing himself

March 8, 2019

- 1) Call 14-47-27_IN
 - FOX states he is working on the website

2) Call 15-30-17 OUT

- FOX mentions he is reading through emails from the "stupid, psycho, cunt" for affidavits
- FOX speaks of his hearing for appeal and speaking with crown counsel Susan Elliot
- FOX can't afford over \$2000 for transcripts
- FOX feels that Susan Elliot had contact with the judge before his court appearance based on the judge's reaction
- FOX played his recoding of a phone call with CBSA to the prosecutor

March 10, 2019

1) Call_18-54-06_OUT

- Call from FOX to MUNOZ
- FOX speaks of importing emails from his computer to MUNOZ
- MUNOZ asking how to delete 3000+ messages
- FOX gives MUNOZ step by step directions on how to delete messages

2) Call 21-44-41 OUT

- Call from FOX to MUNOZ
- FOX still going over emails
- FOX states "she's going to be livid when she sees the new website, all her perjury"
- FOX believes prosecutor won't take action when the new website is online

March 11, 2019

- 1) Call_18-23-33_IN
 - FOX speaking with a male
 - FOX states he is at Starbucks, working on the website.

March 14, 2019

- 1) Call 12-44-54
 - FOX leaving a message for A-TIP
 - Fox confirms his address at 2088 Yukon Street;
 - FOX requests his results be emailed rather than mailed

2) Call_13-11-45_IN

- Call from MUNOZ to FOX
- FOX speaks about court and wanting to amend his conditions
- FOX states the hearing is a courtesy because next week he is going into a CBSA office and they will remove him from the country
- MYHRE hadn't heard the audio recordings about FOX's citizenship
- Angry judge believed MYHRE
- FOX states "it's all on the website now"
- FOX thought he may get arrested at his court appearance because the new website was up and he assumed MYHRE knew about it
- FOX planning on walking through peace arch park March 15, 2019
- FOX doesn't think he will be arrested for breach even if they bring him in at the border
- FOX speaks about emails on the website
- FOX mentions shipping some items to MUNOZ that he doesn't want to carry across the border in case he gets arrested
- 3) Call 13-49-28 OUT

- Call from FOX to MUNOZ
- FOX states "this time tomorrow" he will be dealing with Homeland security at Peace Arch
- FOX mentions he needs to make sure he has everything uploaded from his laptop, he prepaid a cloud account for one year

4) Call 16-24-42 OUT

- FOX states he looked at the access log for the website and noticed lots of activity began around 12:15
- Lots of IP addresses, City of Burnaby, the company that David Georgetti works for and the BC government
- FOX states "so they're definitely aware of the website now"
- Feels timing is weird, after his hearing
- "given that I, no, not I, somebody put all the proof of the misconduct"
- FOX believes that even if he is arrested the website won't come down
- FOX is prohibited from publishing, disseminating material, nothing stops him from maintaining the website from his own computer, if someone publishes it, not him;
- FOX tells MUNOZ he will likely get arrested in the next couple of days
- FOX tells MUNOZ to look at the R. V Fox section of the website as he has added new "stuff;"

5) Call_18-27-46_IN

- Call from Ahmed KHUDHARI ("KHUDARI") to FOX
- FOX tells KHUDARI he thought he was going to get arrested at court, he "pissed the judge off;"
- FOX mentions the activity on the website and IP addresses that have visited it
- FOX doesn't believe police will be able to prove he put the website back up
- FOX is going to report to probation tomorrow and then go to CBSA [KHUDARI's identity has not been confirmed, name taken from contacts in phone]

6) Call 20-23-40 IN

- Call from MUNOZ to FOX
- FOX talks about CAPUANO interview audio on the website
- FOX believes he won't ever be contacted about the website
- MUNOZ concerned FOX will be sent to jail for breaching his probation by running the website
- FOX replies with "prove it," "put me in jail for expressing my opinion"

- FOX mentions that all the new material is about the trial, not harassment
- FOX knows police/crown are going to want to know how he got the transcripts of the trial
- FOX tells MUNOZ if he gets arrested he'll "be in for a long time"
- FOX mentions material he put on the website such as transcripts, audio recordings and RCMP reports
- FOX states he is willing to be locked up for a long time to expose the corruption and awful things CAPUANO has done
- No one will hire CAPUANO now with all of the information on the website
- FOX refers to himself as a martyr for going to jail to expose CAPUANO and states it is his purpose in life
- FOX mentions adding an HTML of collusion and links to emails proving collusion
- FOX mentions that he would refuse to remove the website and would rather be put in jail
- Website is hosted in the United States, decided not to host it in Iceland again to save money
- Canadian government has no authority over GoDaddy
- New website is about CAPUANO, MYHRE, LAGEMAAT, and the judge
- Emails page has emails from MYHRE
- On R. V FOX page FOX admits to putting a picture of everyone and added a blurb about the judge
- FOX will email Dr. Phil to let him know the website is back on
- FOX believes the publishing rights to his story are going to be worth a lot

March 15, 2019

- 1) Call 14-45-12 OUT
 - Call from FOX to MUNOZ
 - FOX sent MUNOZ a tracking number, "don't lose it"
 - FOX threw his tracing number out because he doesn't want the RCMP to know he shipped anything
 - Going to the border
 - FOX tells MUNOZ if she doesn't hear from him in24 hours he has been detained
- 2) Call 16-37-45 OUT
 - Call from FOX to MUNOZ
 - Asking if he should turn himself into CBSA and have them remove him or go straight to Homeland Security?
 - Probation officer told FOX website is being investigated
 - FOX states police won't find anything linking him to the website

- FOX shipped a laptop and removed anything incriminating from it
- FOX states "it's all backed up on internet servers and internet accounts"

Conclusion

FOX has openly admitted to police and crown counsel that he is responsible for the creation and maintenance of www.desicapuno.com.

An examination of FOX's electronic devices has located an overwhelming amount of evidence to support his claim of creating and maintaining the website www.desicapuano.com.

FOX proclaims that as soon as he is released from custody he will ensure the website is running and he will continue to update it because it is his "purpose in life." FOX has dedicated himself to making life as difficult as possible for the victim CAPUANO and believes he is a martyr for exposing her. FOX has a complete disregard for the safety of CAPUANO and puts her safety in jeopardy daily with the personal information he makes available on the website.

FOX was convicted of Criminal Harassment in 2017 creating a website with less content on it than the new website. Police recommend two additional charges of breach of probation based on the distribution of his court documents and his access of the internet. Police also recommend a new charge of criminal harassment as FOX is continuing the offence in which he was convicted of in 2017 and has openly stated he won't stop.

Eventually, I do get deported, I come here to Canada, I 14 lose custody of him, and then she starts making it harder and harder for me to 15 have any contact with him until eventually, she completely cuts off contact. At 16 this point, I've had no contact with my son since 2016. So, as for why, um, 17 because she took my child away from me. 18

 21 able to just shed a few tears and everybody completely forgets all the horrible

- known that the only reason that I was convicted, uh, of criminal harassment was
