

- 28 FOX was released in 2018 and started a new website www.desicapuano.com and
- 29 the Vancouver Police started an investigation VPD file #19-49074. FOX was
- 30 arrested and charged with multiple offences including Failure to Comply with
- 31 Probation Order.

On September 15, 2020 Detective Constable 2671 Jennifer FONTANA (Det. FONTANA) confirmed with FOX's probation officer that he was living at the Belkin House located at 555 Homer St in Vancouver. Det. FONTANA wrote a production order to confirm which dormitory FOX was staying in and which personal locker FOX was assigned at the Belkin House..

On September 16, 2020 the production order was approved and executed by Detective Constable 2341 Rob HOLLAND (Det. HOLLAND) and Detective Constable 2685 Nicole ROBERTS (Det. ROBERTS). FOX was confirmed by staff as living in room 325, bed space 51 and having locker 51.

#### ARREST OF FOX

On September 17, 2020 members of the Domestic Violence and Criminal Harassment Unit attended the Belkin House located at 555 Homer St to execute the search warrant and attempt to arrest FOX for Failing to comply with probation. At 0710 hours Det. ROBERTS arrested FOX using a prepared arrest script (see evidence of Det. ROBERTS). Det. HOLLAND searched FOX incident to arrest and in his possessions was a black Lenovo laptop and a Motorola cell phone, both items were seized at 0718 hours.

### **SEARCH WARRANT**

On September 16, 2020 Det. FONTANA wrote a search warrant to search for any electronic devices that FOX could use to work on the website. Search warrant was approved to search room 325, bed space 51 and locker 51 of the Belkin House located at 555 Homer St on September 17, 2020. On September 17, 2020 at 0808 hours the search warrant was executed on room number 325, bed space 51 and locker 51. Forensic Identification Unit photographed the execution of the warrant. Room 325 has 6 beds and 6 lockers inside. All beds were made and bed 51 was the last bed against a wall. On the floor directly in front of bed 51 was two bankers boxes belonging to FOX according to staff. Det. JORDAN searched the bed and surrounding area and nothing of note was located. Det. JORDAN searched the two bankers boxes that were filled with papers so nothing was seized. Sargent 2179 Mike WHEELER searched locker 51 and seized a device that appeared to be a hard drive or power bank. All items were recorded on an exhibit flow chart.
