UPON THE APPLICATION of Adam Flanders on behalf of the Provincial Crown,
and upon hearing the accused Patrick Fox, on his own behalf,

THIS COURT HEREBY ORDERS THAT: The accused, Patrick Fox, may use
disclosure material provided to him by Crown Counsel, whether given to him in
electronic format or paper copies, solely for the purpose of making full answer in
defence in the matter to which the disclosure materials relate.

AND FURTHER ORDERS THAT: The accused, Patrick Fox, may have access to
the disclosure materials between the hours of 8:30 A.M. and 2:30 P.M., Monday
to Friday, in accordance with arrangements that Crown Counsel has or will make
with North Fraser Pretrial Centre.

AND FURTHER ORDERS THAT: The accused, Patrick Fox, will not change or
disclose to anyone, or attempt to change or disclose to anyone, or reconfigure or
attempt to reconfigure, the password provided to him to access the disclosure
materials, and/or the laptop or hard drive that has or will be provided to him, for
the sole purpose of allowing him to access disclosure materials.

AND FURTHER ORDERS THAT: The accused, Patrick Henry Fox, shall not
reproduce or disclose any of the said disclosure materials and shall not provide
copies of the same to anyone, unless he is represented by Counsel on the matter
to which the disclosure materials relate, in which case the materials may be
provided to that Counsel.

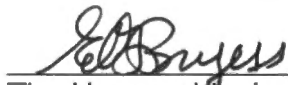
AND FURTHER ORDERS THAT: No information provided to the accused Patrick Fox, as part of the disclosure materials, shall be published, broadcast or transmitted in any way, except in Court, where such information is not subject to a Publication Ban. For greater certainty, this does not apply to any information lawfully obtained by the accused, Patrick Fox, through any third party source, other than Crown Counsel.

AND FURTHER ORDERS THAT: The accused, Patrick Fox, will immediately return the laptop and/or hard drive, on which the disclosure materials are provided to him by Crown Counsel, when any of the following events occur:

- a) if he is to be released from custody, he shall return the laptop and hard drive to the Warden, or his/her designate, prior to leaving the Provincial Correctional Institution where he may be held;
- b) if he is transferred to any other correctional institution;
- c) if the above case has been finally determined

AND FURTHER ORDERS THAT: The accused, Patrick Fox, may be found in contempt of court if he breaches this Order, or uses the disclosure materials for any purpose other than making full answer in defence in the matter to which the materials relate.
