Hello Det./Cst. McElroy,

Thank you for your inquiry. I do recall Mr. Fox calling me within a day or two of his release from custody on April 18th, 2022. He advised me that he had gone to the bail supervisor. My recollection is that his assigned bail supervisor wasn't in at that time, but he said that he did speak to someone else. He advised them that there was nothing he could do about taking the website down. I don't recall specifically why that was but he had some explanation. He then said that because he'd complied with the condition that he advise his bail supervisor of what efforts he'd made in relation to the website, he wouldn't be returning to report to the bail supervisor. I recall telling him that he should report to his assigned bail supervisor and specifically advise what efforts he'd made. Mr. Fox indicated to me that he felt that he had complied and wouldn't be doing that. This is the sum total of what I recall from that conversation.

Det. MCELROY thought that they might show that FOX had more involvement with the website than he alleged. After speaking with Cybercrime, it was determined that these screenshots did not show control of the site. Det. MCELROY flagged them for reference.

Communication:

- Det. MCELROY was not able to locate any communication in the phone that appeared to be to the administrator of desicapuano.com. Det. MCELROY did not locate any emails in the phone. Information located suggests that FOX uses an app called 'bluemail' to receive and send emails. Det. MCELROY was not able to access this app.

Search & Web May 14, 2022 FOX searched:

- Google Webmaster Tools. The description on google shows: "Search Console tools and reports help you measure your site's Search traffic and performance, fix issues, and make your site shine in Google Search results."
- Desiree Capuano

This analysis has been sent to DFU for their final report. Det. MCELROY has requested that they attempt to get further information or potential access to the bluemail app as well as find out if they can determine whether e....@desicapuano.com stands for Editor. In total 27 items were tagged.
