INFORMATION TO OBTAIN

- I, Detective Constable 2343 Amber MCELROY ("Det. MCELROY"), a member of the Vancouver Police Department ("VPD") currently assigned to the Domestic Violence and Criminal Harassment Unit ("DVACH") in the City of Vancouver, Province of British Columbia, solemnly affirm that I have reasonable grounds to believe and do believe the following
- 2. I am a Peace Officer and have personal knowledge of this information in this Information to Obtain ("ITO"), except where otherwise stated. I believe all of the information in this ITO to be true.
- I have been employed by the VPD since February 2004 and I hold the rank of Detective Constable. Prior to being assigned to DVACH, I was assigned to the VPD Operations Division as a Neighbourhood Police Officer and in Patrol.
- 4. During my career I have been involved in many investigations including property crime and violent crimes against persons. I have experience as an affiant, including having applied for and have been granted General Warrants, Search Warrants, Feeney Warrants and Production Orders.
- 5. I have personal knowledge of the matters and facts to which I depose in this Information to obtain, save and except where stated to be on information and belief. As to such

matters, I believe them to be true. Unless otherwise stated, all places referred to in this Information to Obtain are places within the Province of British Columbia.

Unless otherwise stated, all police officers mentioned in this Information to Obtain are members of the VPD.

- 7. Unless otherwise stated, all named locations are in the City of Vancouver, Province of British Columbia.
- 8. I have learned the facts included in this Information to Obtain by:
 - a) Personally investigating this matter.
 - b) Reviewing records contained in the CPIC and PRIME computer databases.
 - c) Communicating personally with other police officers who have conducted the investigation into this matter.
 - d) Reviewing evidence collected by other police officers who have conducted the investigation into this matter. I have not included each and every fact known to me concerning this investigation. I have set forth a full statement of the relevant facts that I believe are necessary to establish reasonable and probable grounds in support of this Information to Obtain.

DEFINITIONS AND ABBREVIATIONS

9. The Canadian Police Information Centre is commonly referred to as "CPIC". CPIC is a computerized data repository maintained by the Royal Canadian Mounted Police (RCMP) in Ottawa, Ontario. It can only be accessed through restricted terminals by authorized persons and is generally accessible by police agencies throughout Canada.

This repository records information including missing persons, wanted persons, stolen property, and criminal records of individuals. CPIC accesses records of motor vehicle branches of the provinces of Canada. These records consist of driver's license information (including names, birth dates, addresses, and driving records) and motor vehicle information for vehicles registered to named individuals through vehicle license numbers. CPIC is also interfaced with the United States National Crime Information Centre, commonly referred to as "NCIC".

10. Police Records Information Management Environment is commonly referred to as "PRIME". PRIME is a computerized repository of information which is maintained by municipal police departments and the RCMP in the Province of British Columbia. PRIME can be accessed only through restricted terminals by authorized persons and is generally accessible by police agencies in the Province of British Columbia. This repository records information collected during police investigations including entities (person, vehicle, and business details), text pages (detailing events and investigations), property pages (detailing property seized, surrendered to or found by police) and attachments; all of which are processed and organized to produce complete police reports.

NAMED OFFENCES

- 11. I have reasonable grounds to believe the following offence has been committed:
 - Two counts of Failure to Comply with Probation Order, contrary to section 733.1 of the *Criminal Code* of Canada.

PERSONS INVOLVED

12. Accused: Patrick FOX (FOX)

13. Victim: Desiree CAPUANO (CAPUANO)

AUTHORIZATION SOUGHT

- 14. A Warrant to Search Pursuant to Section 487 of the Criminal Code to search for the following things currently in police custody:
 - a) The following Exhibits:
 - i. Exhibit 2266177-1: a Black Motorola Smart phone;
 - ii. Exhibit 2266177-2: a Blue Levono Tablet S/N HGA9TE8G;
 - iii. Exhibit 2266177-3: a Lexar USB;
 - iv. Exhibit 2266177-4: Kingston USB;
 - v. Exhibit 2266177-5: a Sandisk Mini SD card with Lexar Adapter; and
 - vi. Exhibit 2266177-6: a Sandisk Mini SD card with Sandisk Adapter.
 - b) The above Exhibits will be forensically examined for the following things/data:
 - Emails from Patrick FOX to the editor of <u>www.desicapuano.com</u>
 between the dates of April 17, 2022, and May 5, 2022;
 - ii. Communication between FOX and the editor of
 <u>www.desicapuano.com</u> and any other person relating to the offence,
 between the dates of April 17, 2022 and May 5, 2022;
 - iii. User account information (that can be used to establish user's identity and the users of the digital device);
 - iv. To determine ownership, use and evidence of the offence.

(Herein referred to as "the Things/Data")

OVERVIEW AND REASON FOR APPLICATION

- 15. FOX and CAPUANO were in a romantic relationship from 2001 to 2003 and during this time they had their child, Gabriel REISS (REISS). While in a relationship with CAPUANO, FOX was known by his biological name Richard REISS but changed his name to FOX in 2014.
- 16. On June 8, 2016, FOX was charged with Criminal Harassment by the Burnaby RCMP (2016-25379) in relation to the creation and operation of a website, www.desireecapuano.com. The website contained some incorrect and defamatory information about CAPUANO, at which time FOX and CAPUANO had a custody battle over REISS. FOX was convicted of Criminal Harassment and Possession of a Firearm at Unauthorized Place.
- 17. On November 10, 2017, FOX was sentenced to 3 years in Jail, with 17 months' time served in custody which was credited as 25.5 months. FOX was given a 3 year probation order with multiple conditions including but not limited to: Not to directly or indirectly disseminate, distribute, publish or make publicly available information, statements, comments, videos, photos which refer or depict by or description Desiree or Sage CAPUANO, James PENDLETON or any of their friends, relatives, employers, coworkers but does not apply to filing documents in legal proceedings or use of documents or information in relation to those legal proceedings.
- 18. After his release on December 30, 2018, it was found that www.desireecapuano.com was now operating under a new web address of www.desicapuano.com. As a result, the Burnaby RCMP and the Vancouver Police Department were notified. At the time of the

- creation of the new website, FOX was believed to living in Vancouver and as such, VPD DVACH took custody of the investigation (VPD 2019-49074).
- 19. As a result of VPD investigation (VPD 2019-49074), FOX was determined to be the creator of the new website www.desicapuano.com and was in breach of his court condition regarding the use of the internet and publishing information about CAPUANO. FOX was convicted of failing to comply with his probation order and received 6 months' time served in custody with a 6 month probation order upon his release on August 19, 2020.
- 20. Upon his release, FOX's probation order stated he had a remove the website www.desicapuano.com within 48 hours of his release. On the day of his release, the website was updated with a letter to David Eby.
- 21. VPD DVACH then began their investigation (VPD 2020-164388) and found www.desicapuano.com to still be active in September 2020. On September 17, 2020, FOX was arrested for failing to comply with his probation order for not removing the website. FOX was convicted of failing to comply with his probation order and received a six month custodial sentence, one year probation and was credited 10 months and 15 days in pre-sentence custody time.
- 22. On August 12, 2021 FOX was released with the condition to remove the website within 48 hours of his release. FOX notified regional Crown in an affidavit that he would not be taking down the website. VPD DVACH was advised of his pending release and intentions to breach his probation condition.
- 23. VPD DVACH then began their investigation (VPD 2021-132224) and found www.desicapuano.com to still be active after the 48 hour time period of FOX's release.

On August 17, 2021 FOX was arrested for failure to comply with his probation order. FOX was convicted of failing to comply with his probation order and received a 2 month, 18 day custodial sentence, 3 years' probation and was credited 6 months and 8 days in pre-sentence custody time.

- 24. On April 17, 2022 FOX was released with the condition to remove the website within 48 hours of his release as well as to report to a Probation Officer within 72 hours of his release.
- 25. On April 28, 2022 VPD DVACH was contacted by Crown to advise that FOX had not taken down the website and that he had failed to report to a Probation Officer within the 72 hour period of his release.

DVACH INVESTIGATION

- 26. On July 15, 2022 Det. MCELROY read the occurrence report (VPD 2022-66177) authored on May 16, 2022 by Det. KIM and learned in part the following:
 - a. On April 28, 2022 VPD DVACH was notified by Crown Counsel regarding FOX's failure to comply with his probation conditions after his release on April 17, 2022:
 - i. Report to a Probation Officer within 72 hours of your release from custody for the purpose of informing your Probation Officer at that time of the exact steps you have taken to comply with the conditions of this Probation Order, with the following condition of this Probation Order that: within 48 hours of your release from custody you shall take all necessary steps to ensure that any website, social media page or any

other publication, with you have authored, created, maintained or contributed to, which contains any information, statements, comments, videos, pictures which refer to or depict, by name or description,

Desiree Capuano or any of her friends, relatives, employers, or coworkers, including the websites published under the domain www.desireecapuano.com and desicapuano.com are no longer available via the internet or any other means. Once you have reported these exact steps you have taken to comply with that condition, you will no longer be required to report to a Probation Officer.

- ii. Within 48 hours of your release from custody you shall take all necessary steps to ensure that any website, social media page or any other publication, which you have authored, created, maintained or contributed to, which contains any information, statements, comments, videos, pictures which refer to or depict, by name or description,

 Desiree Capuano or any of her friends, relatives, employers, or coworkers, including the websites published under the domain www.desireecapuano.com and www.desireecapuano.com and www.desicapuano.com are no longer available via the internet or any other means.
- b. Crown Counsel advised that they were in receipt of the Report to Crown from the Probation Office for his failure to report. Upon conversation with Crown Det. KIM learned the following:

- On April 19, 2022 FOX attended and spoke with Probation Officer
 Supervisor Julia SEATH ("PO SEATH") and was given an appointment
 of April 21, 2022 to meet with his assigned Probation Officer.
- ii. FOX did not attend his appointment on April 21, 2022.

- d. On May 3, 2022 VPD Crime Data Analyst Catherine MEIKLEJOHN ("Analyst MEIKLEJOHN") confirmed that the website www.desicapuano.com had a password protection and the contents of the website could not be seen without the password.
- e. Analyst MEIKLEJOHN further determined that when desicapuano.com was searched on Google Search, the first website on the list had the title "Desicapuano/Desiree Capuano Drug Addict, Child Abuser, White" with the description below as "Exposing the evil, manipulative, narcissistic, sociopathic mother that is Desiree Capuano... Check desicapuano valuation, traffic estimations and owner info..."
- f. On May 5, 2022 Det. KIM attended the Belkin House at 555 Homer St, Vancouver and confirmed that FOX was residing there.
- g. On May 15, 2022 DVACH learned that www.desicapuano.com was now accessible to the public without password protection.
 - i. The website consisted of recent postings from March 29, May 1,May 2, May 6, May 7, May 8 and May 11, 2022.

- ii. Most of the posts have a perspective of "Editor", writing about BC Government admitting the website to be legal, the Probation Officer lying on the witness stand, VPD and Crown mishandling disclosures, and the Judge's delusional judgement;
- iii. A couple of the posts were written in the perspective of "Desiree" claiming to be defrauding the public and using their son to control FOX.
- h. Det. KIM believed FOX was breaching both probation conditions listed in 26(a) i. and 26(a) ii.
- 27. On July 15, 2022 Det. MCELROY reviewed screen captures taken by Analyst MEIKLEJOHN on May 3 and 16, 2022. The May 3, 2022 captures, described below, show that the website was only accessible through a password. The May 16, 2022 captures, described below, show that the website was accessible to the public at that time.
 - a. May 3, 2022:
 - i. <u>www.desicapuano.com</u> was password protected at the time of this search;
 - ii. Desicapuano.com google search resulted in the comments listed in 26(e).
 - b. May 16, 2022:
 - The front page of the website <u>www.desicapuano.com</u> with the title
 "This Website is About Standing Up to Tyranny!";

- ii. www.desicapuano.com article dated Mar 29, 2022 with the title"Probation Officer Abeed Bhimji Caught Lying on the Witness Stand";
- iii. www.desicapuano.com article dated May 1, 2022 with a picture of
 Desiree CAPUANO "I Admitted I've Been Using Our Son as a Pawn to
 Control Patrick";
- iv. <u>www.desicapuano.com</u> article dated May 2, 2022 with the title "BC
 Government Admits This Website is Not Illegal";
- v. www.desicapuano.com article dated May 6, 2022 with a picture of Desiree CAPUANO "I Committed 81 Instances of Perjury";
- vi. www.desicapuano.com article dated May 7, 2022 with a title of "VPD and Crown Counsel Give Patrick Someone Else's Disclosure Material":
- vii. www.desicapuano.com article dated May 11, 2022 with a title of
 "Judge Kathryn Denhoff and Her Delusional Reasons for Judgement".
 This article references disclosure documents from FOX's most recent trial;

ARREST OF FOX

28. On May 16, 2022 Det. KIM, in company of myself, attended the Belkin House at 555 Homer St, Vancouver and arrested and read FOX's Charter Rights for two counts of Failure to Comply with his Probation Order. FOX declined to contact a lawyer.

SEARCH AND SEIZURE OF DEVICES

- 29. Det. KIM, in company of myself, searched FOX incident to arrest and located the following devices inside the black laptop bag that he was carrying at the time of arrest:
 - a) Exhibit 2266177-1: a Black Motorola Smart phone;
 - b) Exhibit 2266177-2: a Blue Levono Tablet S/N HGA9TE8G;
 - c) Exhibit 2266177-3: a Lexar USB;
 - d) Exhibit 2266177-4: a Kingston USB;
 - e) Exhibit 2266177-5: a Sandisk Mini SD card with Lexar Adapter;
 - f) Exhibit 2266177-6: a Sandisk Mini SD card with Sandisk Adapter.
- 30. Det. MCELROY immediately placed Exhibit 2266177-1: a Black Motorola Smart phone into a Faraday tin. Exhibit 2266177-2: a Blue Levono Tablet S/N HGA9TE8G would not fit inside of a Faraday tin.

[Based on my experience as a police officer, I am aware that placing a cellular phone or tablet into a metal Faraday tin blocks the cellular signal which serves to prevent access.]

- 31. On May 16, 2022 I completed the Form 5.2 Report to a Justice. Det. MCELROY secured the following devices in Special Investigation Section secured locker #31 on the 5th floor of 3585 Graveley Street, Vancouver:
 - a) Exhibit 2266177-1: a Black Motorola Smart phone inside of a Faraday tin;
 - b) Exhibit 2266177-3: a Lexar USB;
 - c) Exhibit 2266177-4: a Kingston USB;
 - d) Exhibit 2266177-5: a Sandisk Mini SD card with Lexar Adapter;
 - e) Exhibit 2266177-6: a Sandisk Mini SD card with Sandisk Adapter.

- 32. May 16, 2022 I secured Exhibit 2266177-2, a blue Levono Tablet S/N HGA9TE8G inside of the Digital Forensics Unit ("DFU") locker #001, located on the 2nd floor of 1570 Kootenay St, Vancouver. The Levono Tablet was too large to be stored in a Faraday tin, and I requested that it be stored in the DFU Faraday room.
- 33. On May 17, 2022 Levono Tablet S/N HGA9TE8G was moved into the DFU Faraday room where it remains at the time of writing.

IN-CUSTODY INTERVIEW OF FOX

- 34. On May 16, 2022, at 1259 hours, I conducted an audio and video recorded in custody interview of FOX at the Vancouver Police Annex, located at 236 E. Cordova Street, Vancouver.
- 35. During the interview, I was advised of the following by FOX:
 - a. FOX was in possession of a tablet and a cell phone, both of which were capable
 of accessing the internet.
 - b. On April 18, 2022 FOX emailed the person in charge of the website though the editor email on www.desicapuano.com asking them to take down the site.
 - c. FOX does not know who is currently in charge of the running of the website and claims that he gave up control of the website in 2018.
 - d. FOX said he would be willing to provide a copy of this email at some point, but would not provide any passwords to his devices so investigators could confirm this email existed.

CAPABILITIES OF THE DIGITAL FORENSICS UNIT

- 36. On July 15, 2022, I spoke in person to Detective Constable Robin SHOOK ("Det. SHOOK") of the DFU. Det. SHOOK confirmed that DFU would be able to accomplish the following in regards to data recovery:
 - a. Using forensically sound principles without compromising data integrity; conduct the examination of electronic devices and digital storage mediums, including, but not limited to, storage devices used in computers and mobile devices, external storage devices, Sim Cards, memory cards, and optical media (such as CDs and DVDs];
 - b. That the data extracted from electronic devices and digital storage niediums can include but is not limited to:
 - i. Communication records (such as contacts, call history, messages, email);
 - ii. Media records (such as Images, Videos, and Audio);
 - iii. Documents and spreadsheets;
 - iv. Internet activity; Geo-location records (such as GPS coordinates);
 - v. User account information (that can be used to establish user's identity and users of the digital devices).
- 37. Based on what I learnt from Det. SHOOK of the DFU, I decided on the following scope:
 - a) Emails from Patrick FOX to the editor of www.desicapuano.com between the dates of April 17, 2022 to May 16, 2022;

- b) Communication between FOX and the editor of www.desicapuano.com and any other person relating to the offence, between the dates of April 17,
 2022 to May 16, 2022;
- User account information (that can be used to establish user's identity and the users of the digital device);
- d) To determine ownership, use and evidence of the offence.
- 38. Det. SHOOK advised that the time required to search a digital devices will vary depending on the complexity of the device, its storage capacity, and the scope of the search. Coupled with the work related priorities of DFU, the timeframe required to search a digital device cannot be accurately predicted;
- 39. Det. SHOOK advised that a member of DFU can take custody of the all the devices listed in paragraphs 29(a) to 29(f), between the dates of July 15, 2022, and July 28, 2022; and
- 40. The search of the devices can then be conducted as priorities allow.

JUSTIFICATION FOR AUTHORIZATION SOUGHT

- 41. As I have set out in my Information to Obtain, I believe that upon his release from custody on April 17, 2022, FOX had access to the internet and would have been able to craft and send an email to the editor of the website, www.desicapuano.com.
- 42. During the in custody interview of FOX, he stated he sent an email requesting the person who currently operates the site make it inaccessible to the public or remove its contents.

43. I believe the email sent to the editor of www.desicapuano.com will be located in the devices seized from FOX during his arrest on May 16, 2022.

CONCLUSION

- 44. On April 17, 2022, FOX was released from custody with a condition of his probation to remove the website <u>www.desicapuano.com</u> within 48 hours of his release. As well as to meet and discuss his plans to take down the website with his Probation Officer within 72 hours of his release.
- 45. On May 3, 2022 www.desicapuano.com was still active and accessible and password protected.
- 46. On May 16, 2022 www.desicapuano.com was active and accessible to the public without a password.
- 47. Upon his arrest, FOX stated he had sent an email to the editor of www.desicapuano.com requesting its removal, but has not provided a copy to investigators and will not provide his passwords to his devices in order to confirm this email was sent.
- 48. I believe the email FOX sent to the editor of www.desicapuano.com will be located on one of the devices seized upon his arrest.
- 49. I believe a search of the seized electronic devices listed in paragraph 29(a) to 29(f) will allow investigators to determine if FOX made an attempt to have the website www.desicapuano.com removed.

TIME FRAME FOR WARRANT EXECUTION

50. The DFU currently has a limited number of digital forensic examiners available to conduct forensic examinations and they have other active, priority investigations pending; the majority of which are complex homicides, violent assaults, sexual assaults as well as child pornography and large drug investigations. I respectfully request that the Search Warrants for the devices be valid for a two week timeframe from July 15, 2022 to July 28, 2022 in order to execute the warrants and begin the forensic examination of these devices.
