Thanks again for speaking to me regarding Mr. Patrick Fox. As I understood from our conversation, Mr. Fox is due to be deported back to Canada by the US authority. I would like to request that his Firearms Licence (PAL) to be seized for public safety reasons and either return it to my office or return to Cst. Denise Kam of the Burnaby RCMP. I have copied Cst. Kam on this email to see if she wish to be notified upon Mr. Fox's re-entry to Canada for follow up.

If an interview can be conducted with Mr. Fox, I would like to know his home address in Canada and where he is storing his firearms, including restricted and non-restricted firearms.
