Text: **Subject entered office from within Canada and stated that he wanted to go back to the USA. He states that he is a US citizen (does not have proof of any citizenship) but has been removed multiple times by US authorities back to Canada. He states that IRCC and CBSA have both stated he is not a Canadian citizen. Passport Canada was called and confirmed Riess, Richard DOB: 1973/11/24 was issued a Canadian passport and that he was born in Sudbury, ON. NCMS note states that Edmonton CIC confirmed RIESS was born in Sudbury, ON. When questioned about this, subject states that he stole RIESS's identity and fraudulently applied for a Canadian passport and received it. Subject states he stole RIESS's identity because it is not identity theft if you steal someone's identity that is not in the USA. Subject states that he has no claim to Canadian citizenship and neither do his parents. He states that he was born in Florida. When asked if he has proof of this he stated he has a Birth Certificate in a safety deposit box in Florida that shows him being born as FOX, Patrick DOB: 1973/11/24. Subject states he was born FOX, assumed RIESS's identity and has subsequently returned to using FOX. Both names had multiple arrests in Canada and USA. At this point, it cannot be confirmed that subject is NOT a Canadian and his explanation of stealing RIESS's identity cannot be confirmed. When asked how he found RIESS he was hesitant and then said through a friend of a friend, I asked why this person and he said, because they shared the same birth date. Subject has been in contact with IRCC, CBSA, RCMP and has correspondance in documents as well as on his phone with all three parties. All of whom seem to agree that he is a Canadian. When informed since subject does not have proof of US citizenship and since he has been previously removed numerous times from the US, he is unlikely to be allowed entry. He says he is hoping to get detained because he will refuse to be removed and then he can sort this all out and prove that he is in fact FOX, a US citizen and stole RIESS's identity at some point in the past.**
